STIPULATION AUTHORIZING ELECTRONIC SERVICE

The parties, by and through their respective counsel request entry of an Order authorizing

electronic service in this matter as follows:

1. The parties have investigated the electronic services offered by LexisNexis; and

2. The parties have found that the proposal from LexisNexis to serve as the e-serve

agent in this proceeding would facilitate proper and efficient service; and

3. Each party, through the undersigned counsel, has received information on how to

electronically serve documents and will enter into their own agreements with LexisNexis.
