**ORDER CONSOLIDATING, TRANSFERRING AND DESIGNATING THE  
MARCELLUS SHALE LITIGATION FOR ELECTRONIC FILING AND SERVICE**

Pursuant to West Virginia Trial Court Rule 26.08(b), and with the advice and consent of the Panel, the cases in the attached Exhibit A are **ORDERED** consolidated under the style, "*In re: Marcellus Shale Litigation*, Civil Action No. 14-C-3000" to facilitate the Panel's case management and trial methodologies.

The Panel has determined it is appropriate for the Marcellus Shale Litigation to be subject to electronic filing and service ("e-filing and service") and, therefore, **ORDERS** the litigation

transferred to the Circuit Court of Ohio County, West Virginia, *solely for purposes of implementing electronic filing and service*. The paper court files for the cases listed on Exhibit A, as well as the paper court files for any subsequently-filed cases the Panel orders joined with the Marcellus Shale Litigation will remain in the circuit courts where the cases originated, until further order of the Court.

Pursuant to West Virginia Trial Court Rule 15.02(c), the Panel **ORDERS** all cases in the Marcellus Shale Litigation designated for e-filing and service, **beginning on December 15, 2014**, as provided in Trial Court Rule 15.01 *et seq.* All documents filed prior to December 15, 2014, shall be filed in the circuit courts where the cases originated. All oversized documents that cannot be electronically filed and all documents that the Court orders to be placed under seal in the court file will be traditionally filed in the circuit courts where the cases originated.

Registration and training for e-filing and service is **mandatory**. If a party is not registered with File & Serve*Xpress* by **December 15, 2014**, the party will not receive e-service of documents in the Marcellus Shale Litigation. Even if a party has registered and received training for e-filing and service in other Mass Litigation cases, there will be specific training for e-filing and service in the Marcellus Shale Litigation that all parties must receive. Communications will be forthcoming from File & Serve*Xpress* regarding registration and training, but the **File & Serve*Xpress* Customer Service Department** may be reached at **1-888-529-7587** if you have any questions.


The Panel reminds the parties that, pursuant to Trial Court Rule 15.02(b), e-filing and service shall not be used to initiate a civil action or to serve a new party with an amended complaint or a third-party complaint.

As previously ordered, a Status and Scheduling Conference will be held at **10:00 a.m. on December 22, 2014**, in **Courtroom Four**, also known as the Ceremonial Courtroom, on the Second Floor of the Kanawha County Courthouse, at 409 Virginia Street, East, in **Charleston, West Virginia**. All counsel of record and any self-represented parties are **ORDERED** to attend and shall be prepared to discuss:

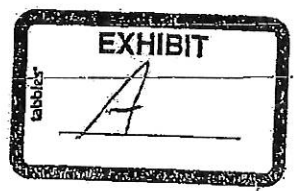
1. Appointment of Liaison Counsel;
2. *Pro hac vice* admissions;
3. Status of pretrial discovery;
4. Status of pending discovery motions and dispositive motions;
5. Proposed trial schedule;
6. Prior mediation and status of settlement negotiations; and
7. Status of implementation of electronic filing and service.

The Clerk of the Circuit Court of Harrison County, West Virginia, is **ORDERED** to file this order and provide a certified copy of this Order to the Circuit Clerks of Ritchie, Doddridge, Marion, Pleasants, Kanawha and Monongalia Counties, and to the Mass Litigation Manager. The Circuit Clerks of Harrison, Ritchie, Doddridge, Marion, Pleasants, Kanawha and Monongalia Counties are **ORDERED** to record this Order in each of the cases identified in the attached Exhibit A that are pending in their county and to provide copies of this Order to all parties of record or their counsel.
