24 Pursuant to the stipulation of parties, and good cause appearing,

25 IT IS ORDERED as follows:

26 Effective October 1, 2004, pursuant to Rule 124 of the Supreme Court of Arizona,

1 all attorneys who have appeared on behalf of their respective parties (“counsel of record”)
2 in this case may use LexisNexis File & Serve to receive electronic service and
3 electronically serve any and all pleadings, motions or any other document requiring
4 service on counsel of record.

5 Electronic service via LexisNexis File & Serve shall be considered as valid and
6 effective on all designated recipients pursuant to A.R.S. Title 12, inclusive.

7 Every pleading, document and instrument served electronically shall bear a
8 facsimile or typographical signature (/s/) of at least one of the attorneys of record, along
9 with the typed name, address, telephone number and State Bar of Arizona number of such
10 attorney. Typographical signatures shall be treated exactly as personal signatures for
11 purposes of electronically served documents under the Arizona Rules of Civil Procedure.

12 To address any training or technical questions that may arise during the course of
13 this litigation, LexisNexis File Serve shall have available to counsel of record and the
14 Court a 24-hour 7-days a week customer service resource at (888) 529-7587.

15 Within 10 days of this Order, each attorney of record shall register to use Lexis File
16 & Serve (Advanced) located at <http://www.lexisnexis.com/fileandserve>.

17 This Order shall apply only to the electronic service of documents upon counsel of
18 record. Counsel or parties filing original documents with the Court shall do so manually
19 with the Clerk of the Court following existing filing procedures pursuant to the Arizona
20 Rules of Civil Procedure.
