ORDER AUTHORIZING ELECTRONIC SERVICE

It is this 31st day of July 2007, hereby

ORDERED:

1. As of the date hereof, pursuant to the Maryland Rules of Civil Procedure, all attorneys who have appeared on behalf of their respective parties ("counsel of record") in this case shall use LexisNexis File & Serve to serve any and all pleadings and discovery-related documents requiring service on counsel of record. Each attorney may also use LexisNexis File & Serve to serve correspondence.

shall do so manually with the Clerk of the Court following existing filing procedures pursuant to the Maryland Rules of Civil Procedure.










